- All tables should be covered. Empty boxes and clutter should be stored out of sight. We as that all booths be presented in a professional manner.
- Smoking is not allowed in CVE buildings. Please use designated areas for smoking using public exits and entrances. **DO NOT USE EMERGENCY EXIT DOORS OR PROP DOORS OPEN AT ANY TIME DURING EXPO HOURS**
