Campground Rules and Regulations

The following rules apply to all Champlain Valley Exposition events to which the campground is open. Violation of the CVE Campground rules may constitute removal from the campground and Exposition grounds.

1. Check in is between the hours of 1:00 pm and 7:30 pm. Check out time: 11:00 am.
2. All reservations are subject to availability. Non-refundable deposit equal to one night fee per reservation is required.
3. Reserved sites will not be held after 8:00 pm of the scheduled check in date. The non-refundable deposit will be forfeited.
4. Prices are subject to change without notice.
5. One RV (or tent), and one vehicle per site. Please park in front of your camping unit at your campsite. Additional vehicles will be parked elsewhere.
6. Due to site limitations, Campers may have to choose between use of slide out or awning. Not to extend beyond lines designating each camp site.
7. All visitors must register at the Campground Office.
8. Speed limit – 5 mph or less.
9. Quiet time: 10:30 pm to 7:00 am.
10. Use of RV or portable emergency generators is prohibited.
11. Alcoholic beverages must be contained at camp site.
12. Unbecoming or unruly behavior will not be tolerated.
13. Pets must be under control at all times. Pet owners will be held responsible for damage caused by pets. Noisy or unattended pets will not be tolerated.
14. Please clean up after your pet.
15. Washing of RVs or vehicles not permitted on campground.
16. No liquid wastes allowed on ground surface. This includes sewage and gray water.
17. Arrangements for next day pump out of RV holding tanks must be made at the Campground Office. Pump out fee is \$20. This campground does not have a dump station therefore we must charge to dump your waste.
18. Cutting, chopping or putting nails in trees is prohibited.
19. Sites are to be kept neat at all times. Please dispose of trash in dumpsters located on the campground.
20. Please do not go on neighboring properties.
21. Thank you for cleaning your camp site before leaving.
